**Sub: Participation of SSI/micro units in International Trade Fairs/Exhibitions, Organised by SIDO.**

Sir,

Small Industries Development Organization (SIDO) under the Ministry of Micro, Small and Medium Enterprises is scheduled to participate in 8 Nos. of International Fairs/Exhibition listed as under during 2007-08 as an export mark of development/promotion measure for the Micro and Small Industrial units.

**Expenses to be reimbursed to the MSME/KVI/Coir Board entrepreneurs for their Joint participation from a common platform.**

Sl.No.	Item of expenditure	Norms /Scale of Assistance
1.	Space Rent	Upto 50% of the space rent actually paid. In case of Women entrepreneurs/SC & ST entrepreneurs and entrepreneurs from North Eastern Region, upto 100%
2.	Travel Expenses	Upto 75% of the air fare by economy class or train fare, as the case may be. In case of Women entrepreneurs/SC & ST entrepreneurs and entrepreneurs from North Eastern Region, upto 100% of the air fare by economy class or train fare actually paid.

**Assistance for space rent and travel expenses for each participating entrepreneur/unit would be limited to Rs. 1.25 lakh.**

Each participating unit could book a minimum of 9 sq. m (3 m x 3 m) of space. If anybody wants more space, they can book in multiple of 1 x 3 sq. m and would be required to pay on pro-rata basis. It may also be made clear to the participating units that the space would be provided on the basis of lay-out plan, location and availability of space etc as decided by the deputed SIDO officers to that fair and their decisions shall be binding on participants. The quality of the product must be of international standards or units having ISO: 9000/14000 Certification may apply.
